On the early afternoon I was able to make contact with Mr Eisner. I asked if Ms Green was looking for immunity, or an excuse not to speak with the officers. I offered to arrange immunity. Mr Eisner advised that Ms Green did not wish to speak with police.

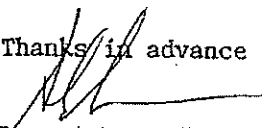
Ms Green has knowledge of the homicide and I am confident that she was not present when it occurred. She was present when Stanley Jalowiec and Raymond Smith returned to Elyria on 011994 after they had killed Ron Lally. Since she and Dan Smith lived together for some time I am confident that she was privilege to conversations between Dan Smith and others, before and after, concerning the homicide.

I request that Tammy Green Aka Tammy Castro, [REDACTED], Cleveland, SSN [REDACTED], DOB [REDACTED] be given immunity, and subpoenaed to testify before the Lorain County Grand Jury as soon as possible.

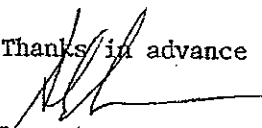
