FOLLOW-UP REPORT ☐

ON THURSDAY, FEBRUARY 17, 1994, WHILE ASSIGNED TO HOMICIDE CAR 8153, IN COMPANY WITH DET. ROBERT MOORE, WE RECEIVED AN ASSIGNMENT FROM SGT. SKORICH, HOMICIDE UNIT O.I.C., TO FOLLOW UP ON THE ABOVE CRIME. BELOW ARE THE RESULTS OF OUR INVESTIGATION.

ON THE ABOVE DATE WE RESPONDED TO 2370 EAST 69TH, WHICH IS LOCATED DIRECTLY ACROSS FROM WOODLAND CEMETERY. THERE WE SPOKE WITH GLORIA CHESTER BF 59, DOB [REDACTED] WHO LIVES DOWNSTAIRS AT THIS ADDRESS WITH A TX#391-8511. MS. CHESTER TELL US ON THE MORNING THE ABOVE VICTIM WAS FOUND, SHE HAD SLEPT ALL NIGHT AND DIDNOT HEAR OR SEE ANYTHING UNUSAL IN OR AROUND THE CEMETERY BEFORE GOING TO BED. MS. CHESTER SAYS SHE AWAKENED AT APPROXIMATELY 0930 HOURS AND NOTICED THE POLICE CAR IN THE CEMETERY AT THAT TIME.

WE THEN WENT UPSTAIRS AT THIS ADDRESS AND SPOKE WITH VANNESSA SPEARS BF 39, DOB [REDACTED] TX#391-3835. SHE REPORTS NOT WITNESSING ANYTHING UNUSAL DURING THE NIGHT IN OR AROUND THE CEMETERY. SHE SAYS THAT IT WAS UNUSAL, BECAUSE SHE NORMALLY SEE POLICE CARS PATROLING DURING THE NIGHT AROUND THE CEMETERY BUT NON THE NIGHT BEFORE THE VICTIM'S BODY WAS FOUND. MS. SPEARS SAYS THAT THE CEMETERY IS A KNOWN HANG OUT FOR PROSTITUTES BOTH WHITE AND BLACK, AND ARE CONSTANTLY BEING RAN OUT OF THE AREA BY THE PATROL CARS. WHEN ASKING THIS FEMALE IF SHE HEARD ANY GUN SHOTS DURING THE EARLY MORNING HOURS FROM THE CEMETERY, SHE REPORTS BEING UP ALL THAT NIGHT DUE TO ILLNESS, AND HEARING NO GUN SHOTS.

AFTER CONDUCTING THE ABOVE INTERVIEWS WE RESPONDED TO ELYRIA, OHIO, WHERE WE WENT TO THE PARKER & HANNIFIN AIRBORNE DIVISION PLANT LOCATED AT 711 TAYLOR ST., WHERE WE MET WITH SANDRA WILLIAMS. (VICTIM'S EX-GIRLFRIEND) WHO IS MENTIONED IN PREVIOUS REPORTS IN THIS INVESTIGATION. SANDRA REPORTS KNOWING THE VICTIM 13 YEARS, AND LIVING WITH HIM DURING MOST OF THAT TIME, UNTIL CHRISTMAS OF 1992. SHE SAYS THEY SEPARATED DUE TO VICTIMS INCREASING DRUG PROBLEM, IN WHICH HE STOLE HOUSEHOLD FURNITURE, APPLIANCES, AND HER CAR FOR DRUGS. SANDRA SAYS EVEN AFTER SHE AND THE VICTIM SEPARATED THEY CONTINUED TO SEE EACHOTHER ON A REGULAR BASIS. SHE REPORTS THE VICTIM RECENTLY TALKING FO SUICIDE, BUT HAS NEVER ATTEMPTED SAME. SHE REPORTS THE VICTIM OWNED A 1980 BUICK CENTURY, WHITE IN COLOR, BUT SHE HAS NOT SEEN THIS VEHICLE SINCE NOVEMBER/1993. SHE SAYS VICTIM HAS BEEN KNOWN TO RENT AND TRADE HIS CARS FOR CRACK IN THE PAST. SHE SAYS WHEN SHE LAST ASKED THE VICTIM ABOUT HIS CAR DURING CHRISTMAS/1993, HE TOLD HER HE HAD JUNKED THE VEHICLE BECAUSE OF MAJOR PROBLEMS WITH THE BRAKES AND WHEELS. SANDRA WENT ON TO REPORT THE LAST TIME SHE SEEN THE VICTIM WAS JANUARY 08, 1994, AND THEY SPENT THE DAY TOGETHER AT HER APARTMENT, ON YORK-LANE DRIVE... WHEN ASKING THIS FEMALE ABOUT VICTIM'S FRIENDS AND ASSOCIATES, SHE REPORTS VICTIM HAD STARTED TO HANG OUT WITH A BLACK FEMALE WHOM HE INTRODUCED TO HER AS DONNA, AND A COUPLE OF HER FRIENDS WHOS NAMES SHE DIDNOT KNOW. SANDRA SAYS SHE MET THIS DONNA IN DECEMEBR/1993 AT THE VICTIM'S APARTMENT. SANDRA SAYS SHE FOUND THESE PEOPLE BEING THERE UNUSAL BECAUSE BEFORE LAST YEAR VICTIM WAS EXTREAMELY PREJUDICE AGAINST BLACKS. BEAMAN - MOORE DETS.

FOLLOW-UP REPORT ☐

JIM SNYDER:

INTERVIEW SAYS VICTIM WAS AVOIDING HIM BECAUSE OF NON-PAYMENT OF RENT. JIM SAYS WHEN HE LAST SAW VICTIM IN DECEMBER, VICTIM TOLD HIM HE WOULD PAY HIM WHEN HIS UN-EMPLOYMENT CHECK ARRIVES, WHICH WAS DUE JANUARY 10, 1994. JIM SAYS AFTER NOT SEEING VICTIM AFTER THAT DATE, HE CALLED THE UNEMPLOYMENT SERVICES PRETENDING TO BE VICTIM, ASKED ABOUT HIS CHECK, AND WAS TOLD THE CHECK HAD ARRIVED AND WAS CASHED. JIM SAYS AT THIS POINT HE PLACED AN EVICTION NOTICE ON VICTIM'S APARTMENT DOOR ON JANUARY 25, 1994. JIM SAYS THAT WHILE HE WAS ATTEMPTING TO CATCH THE VICTIM AT HOME HE WENT TO THE VICTIM'S APARTMENT ON JANUARY 14 OR 15, AND FOUND HIS APARTMENT DOOR UNLOCKED WITH THE LIGHTS AND STEREO ON. HE SAYS HE DID NOT BECOME ALARMED BY THIS BECAUSE OTHER TENANTS HAD REPORTED SEEING VICTIM.

JIM WENT ON TO SAY THAT HE WAS ALSO EVICTING THE VICTIM DUE TO THE LARGE AMOUNT OF VISITOR: D NOISE FROM THE APARTMENT. HE REPORTS BOTH BLACKS AND WHITES, MALES AND FEMALES COMING TO THE VICTIM'S APARTMENT. HE SAYS IN DECEMBER/93, WHILE THE VICTIM HAD COMPANY HE RECEIVED A COMPLAINT FROM ONE OF THE TENANTS ABOUT NOISE. HE WENT TO THE VICTIM'S APARTMENT AND FOUND A MALE NAME STAN JALOWIEC, WHOM HE HAD EVICTED IN THE PAST FOR DRUGS AT THE VICTIM'S APARTMENT. AT THAT TIME HE DEMANDED THAT THIS MALE LEAVE THE PREMISES, AND NOT TO RETURN. INTERVIEW WENT ON TO REPORT ALSO IN DECEMBER/93, EXACT DATE UNKNOWN, A BLACK MALE CAME TO ROOMING HOUSE LOOKING FOR THE VICTIM. HE SAYS THIS MALE WAS VERY IRRATE, BANGING ON THE VICTIM'S DOOR, CALLING HIM MOTHER FUCKERS, AND THREATENING THAT HE WAS GOING TO KILL THE VICTIM FOR WEARING A WIRE AND SETTING HIM UP. INTERVIEW SAYS HE LATER LEARNED FROM ANOTHER TENANT NAME ANDRE GOODWIN, IN APARTMENT #17, THIS MALE NAME TO BE DANNY SMITH, AND A DRUG DEALER. JIM SAYS DURING THIS INCIDENT THE VICTIM WAS INSIDE HIS APARTMENT BUT REFUSED TO OPEN THE DOOR.

JIM SAYS HE LATER AGAIN OBSERVED THE MALE NAME STAN JALOWIEC IN THE VICTIM'S APARTMENT AND AGAIN ASKED THAT HE KEEP THIS MALE AWAY FROM THE BUILDING. HE WAS FURTHER TOLD BY THIS ANDRE GOODWIN THAT STAN JALOWIEC IS A CLOSE FRIEND OF THE DRUG DEALER NAME DANNY SMITH WHO WAS THREATENING TO KILL THE VICTIM. WHEN ASKING THIS INTERVIEW ABOUT THE FEMALE KNOWN AS DONNA, HE SAYS HE ONLY KNOWS HER TO BE A BLACK FEMALE THAT VISITS THE VICTIM, ALONG WITH OTHER UN-WANTED COMPANY. AT THIS TIME WE LEFT A CARD WITH JIM AND REQUESTED THAT HE HAVE THE MALE ANDRE GOODWIN CALL US AT THE HOMICIDE OFFICE.

AT THIS TIME WE WENT TO THE ELYRIA POLICE DEPARTMENT WHERE WE MEANT WITH DETECTIVE LEIBY ALONG WITH DETECTIVE DANIEL JAYKEL, AND THE FOLLOWING INFORMATION WAS LEARNED;

PER DETECTIVE AL LEIBY, VICTIM WAS A CONFIDENTIAL INFORMANT AND DID MAKE (2) SEPARATE DRUG PURCHASES OF COCAINE FROM DANNY SMITH, CAUSING INDICTMENTS FOR DRUG TRAFFICKING AGAINST DANNY AND HIS FATHER RAMOND SMITH AKA JACK FROST, AS REPORTED IN PREVIOUS REPORTS IN THIS INVESTIGATION.
