ON THIS DATE WHILE ASSIGNED TO HOMICIDE CAR 8153, IN COMPANY WITH DETECTIVE MOORE#836, WE RECEIVED AN ASSIGNMENT FROM SGT. SKORICH, HOMICIDE UNIT O.I.C., TO FOLLOW UP ON THE ABOVE CAPTIONED CRIME. BELOW ARE THE RESULTS OF OUR INVESTIGATION.

PURSUANT TO THE INVESTIGATION CONDUCTED IN C/W THIS MALES DEATH BY DETECTIVE STEVERS OF THIS UNIT ON WEDNESDAY, FEBRUARY 09, 1994, WE SPOKE WITH A TAMMY LALLY, WHO STATED THAT HER BROTHER IN LAW WAS MISSING FROM ELYRIA, AND FELT THAT OUR VICTIM'S DESCRIPTION CLOSELY RESEMBL THAT OF HER BROTHER IN LAW RONALD LALLY. AT THIS TIME ARRANGEMENTS WERE MADE TO MEET WITH MS. LALLY AND OTHER FAMILY MEMBERS AT THE CUYAHOGA COUNTY CORONER'S OFFICE AT 1000 HOURS THIS DATE

AT THE CORONER'S OFFICE IN COMPANY WITH DR. HEATHER RAAF, WE MET WITH THE FOLLOWING MEMBERS OF THE LALLY FAMILY AND AT THIS TIME THEY ALL POSITIVELY IDENTIFIED THE ABOVE VICTIM.

AT THIS TIME WE LEARNED THE VICTIM TO BE RONALD J. LALLY WM 30, DOB 06-01-63, SS# [REDACTED] ADDRESS OF 516 MIDDLE AVENUE ELYRIA, OHIO, APT. #14, NO PHONE. FAMILY MEMBERS REPORTS VICTIM LIVED ALONE AT THE ABOVE ADDRESS AND HAD RECENTLY SEPARATED FROM HIS LONG TIME GIRLFRIEND SANDRA WILLIAMS (ADDRESS AND PHONE UNKNOWN). HE WORKED CONSTRUCTION BUT WAS ALSO RECENTLY LAID-OFF FROM HIS JOB. THEY FURTHER REPORT THE LAST TIME VICTIM WAS SEEN HE WENT TO HIS PARENTS HOUSE (WILLIAM & MARLENE LALLY 7299 COUNTY RD. WEST SALEM, OHIO) ON JANUARY 17, 1994, WHERE HE WASHED AND STAYED FOR DINNER. HE LEFT THEIR HOME AT APPROXIMATELY 1700 HOURS AND WASN'T SEEN OR HEARD FROM SINCE. (WILLIAM LALLY) STATES HE AND HIS WIFE TAMMARA WERE NOTIFIED ABOUT 2 WEEKS AGO BY VICTIMS JOB THAT HE HAD NOT RETURNED FOR WORK AFTER LAY-OFF AND AT THIS TIME THEY WENT TO HIS APARTMENT AND FOUND SAME UNLOCKED, BUT NOTHING SEEM TO BE DISTURBED. VICTIM'S APARTMENT DOOR ALSO HAD A EVICTION NOTICE PLACE ON DOOR BY THE LANDLORD. WILLIAM FURTHER STATES THAT UPON ENTERING HIS BROTHER'S APARTMENT THEY FOUND A NOTE FROM A FEMALE KNOWN AS DONNA STATING THAT SHE HAD BEEN BY THE HOME.... THIS FEMALE IS KNOWN ONLY AS A BLACK FEMALE. ABOVE FAMILY SAYS AFTER LEAVING VICTIMS HOME THEY CONTACTED HIS EX-GIRLFRIEND SANDRA WILLIAMS AND WAS TOLD BY HER THAT SHE HAD NOT SEEN VICTIM, BUT WAS TOLD BY VICTIM HE WAS GOING TO BE WIRED UP FOR A COCAINE BUY FOR THE SPENCER POLICE DEPARTMENT.

INTERVIEW WITH FAMILY

ALL FAMILY MEMBER REPORT VICTIM TO BE HEAVIELY INVOLVED IN DRUG USAGE SINCE HE WAS 14 YEARS OLD. HE HAS BEEN IN AND OUT OF DRUG RE-HAB CENTERS BUT ALWAYS RETURNED TO DRUGS AFTER A SHORT PERIOD OF TIME. HE WAS KNOWN TO USE ALL TYPES OF DRUGS (MARIJUANA, HERION, AND COCAINE).

RENEE KRZYNOWEK (SISTER) SAYS DURING THE CHRISTMAS SEASON OF 1993, HER BROTHER WAS SEVERELY DEPRESSED OVER HIS DRUG HABIT AND HIS INABILITY TO QUIT SAME, BUT NEVER ATTEMPTED OR SPOKE OF SUICIDE.... SHE REPORTS VICTIM WOULD GET HIGH ON DRUGS AND LOSE CONTROL, AND SOMETIMES BECOME VIOLENT. SHE FURTHER STATES THAT VICTIM WAS KNOWN TO FREQUENT THE LEAVITT ROAD APARTMENTS IN LORAIN, OHIO, AND THE WILKES VILLA APARTMENTS IN ELYRIA, OHIO WHEN HE BROUGHT HIS DRUGS. RENE SAYS THAT VICTIM HAD CLEANED UP IN THE RE-HAB CENTER BUT RETURNED TO DRUG USAGE DURING DECEMBER/93. HE WAS ALSO KNOWN TO HANG OUT WITH A FRIEND BY THE NAME OF RALPH ZINNER, AND RALPH WOULD KNOW MORE ABOUT WHO THE VICTIM WAS INVOLVED WITH DURING HIS DRUG BENGES.....WHEN ASKING THESE FAMILY MEMBERS ABOUT VICTIM'S TRANSPORTATION, THEY REPORTED THAT VICTIM DID OWN A 1980 BUICK, BUT WHEN LAST TALKING TO VICTIM HE REPORTED ONCE THAT THE BRAKES WERE BEING FIXED BY A FRIEND AND HE DIDN'T HAVE THE MONEY TO PAY FOR SAME, AND SECOND HE REPORTED JUNKING THE VEHICLE FOR MONEY. AT THIS TIME ALL FAMILY MEMBER REPORT HAVING NO KNOWLEDGE OF VICTIMS WHEREABOUTS..... WHEN ASKING THESE FAMILY MEMBER ABOUT VICTIMS FRIENDS IN THE CLEVELAND AREA, THEY REPORT THEIR FAMILY LIVING IN THE CLEVELAND AREA IN THE OLD BROOKLYN SECTION UNTIL 1979, BUT NOT KNOWING VICTIM TO COME TO CLEVELAND SINCE THAT TIME.....WHEN ASKING FAMILY FURTHER ABOUT VICTIM'S DRUG PURCHASES, THEY REPORTED THAT VICTIM HAD RECENTLY STATED THAT SEVERAL BLACK MALES WHOM THEY DIDNOT KNOW WERE AFTER HIM FOR A DRUG DEBT, AND BELIEVES HE GAVE HIS CAR TO THEM FOR SAME..... (NOTE; CHECKING THIS MALE VICTIM FOR VEHICLE THRU LEADS REVEALS HIM TO OWN A 1980 BUICK OHIO LICENCE# NRQ 858)..... AT THIS TIME ALL FAMILY MEMBERS STATED THAT THEY WILL ATTEMPT TO OBTAIN FURTHER INFORMATION ON VICTIMS FRIENDS SANDRA WILLIAMS AND RALPH ZINNER, AND CONTACT THIS OFFICE WITH SAME.

WHILE TYPING THIS REPORT WE RECEIVED A CALL FROM DETECTIVE AL LEIBY OF THE ELYRIA POLICE DETECTIVE BUREAU (332-1926) WHO REPORTED RECENTLY BEING ASSIGNED TO THE DETECTIVE BUREAU BUT PRIOR TO THIS ASSIGNMENT HE WAS IN THE NARCOTICS DIVISION. DURING HIS ASSIGNMENT IN NARCOTICS THE VICTIM WAS A INFORMANT AND HAD MADE 2 CONTROLLED PURCHASES OF COCAINE FOR HIM, ON 06-07-93 AND 06-08-93, FOR \$100.00 APIECE FROM A DAN SMITH BM 21, DOB 11-23-71, SS# [REDACTED] ADDRESS 1446 W. RIVER ROAD NORTH APT#L ELYRIA, OHIO. AS A RESULT OF THESE CONTROLLED PURCHASES BOTH DAN AND HIS FATHER RAYMOND SMITH AKA JACK FROST BM 53, DOB 12-23-39, SS# [REDACTED] SAME ADDRESS AS SON, WERE INDICTED FOR AGGRAVATED TRAFFICKING COCAINE. SINCE THIS INDICTMENT HE RECEIVED INFORMATION FROM RONALD LALLY'S GIRLFRIEND SANDRA WILLIAMS LAST KNOWN TO LIVE AT 59 YORK TOWN LANE ELYRIA, OHIO TX#324-7403, THAT DAN SMITH HAS THREATENED TO BURN OR BLOW UP VICTIMS PARENTS TRAILER, AND KILL HIM.
